We started this several years ago at the urging of an economic development contractor with Pratt and have maintained it each year. This is an accomplishment for us to maintain a successful service that landlords are using. A couple of members engage in going to meeting and staying informed. A few agents met with a representative of Sen Moran's office to discuss affordable housing issues facing rural Kansas via a zoom call.</p>
